



## **Application for Nevada Educational Choice Scholarship Program Tax Credit**

Nevada Revised Statute ("NRS") 363B.119 states that any taxpayer who is required to pay Modified Business Tax pursuant to NRS 363A.130 and 363B.110 may receive a credit against the tax otherwise due for any donation of money made by the taxpayer to an approved Scholarship Grant Organization ("SGO") by the Nevada Department of Education.

- Complete the form below and return it to Silver State Scholarships. Silver State Scholarships will submit the application to the Nevada Department of Taxation ("Department") for approval. The Department will contact us with the decision within about 14 days of submission. If approved, you will have 30 days from date of the Department Approval letter to remit the funds to Silver State Scholarships. Silver State Scholarships will send proof of your remittance to the Department who will then send you a credit letter to the mailing address on your application.

### **Important Notes:**

- Failure to complete the application or illegible information may result in a delay of processing your application, which could extend the 20-day approval period and risk being moved down the line for credit requests
- Any funds **not** remitted within the 30 days, will result in a forfeiture of the application and you will need to submit a new application. (Funds may not be available for you or other SGOs once forfeited)
- You may not utilize the credit until you receive the approval letter sent by the Department
